Whether you're a single plant operator or a large multi-asset organization, the insight derived from this analysis helps establish:


- Meaningful opportunities for risk reduction.

Marsh's risk ranking system provides an absolute measure of risk quality when compared against a defined set of criteria. This proprietary system has been developed and enhanced over the past 25 years and is based on the views of both Marsh's risk engineers and those of the underwriting market. Our risk ranking will:

- · Provide an independent assessment of risk quality.
- Support insurance placement by providing an objective presentation of risk and contributing influencers.
- Facilitate risk improvement by providing comparisons with best practice.
- Provide risk benchmarking offering systematic assetto-asset risk comparison – by asset type, region, or organization. Risk quality, by industry segment, can be benchmarked against assets from across the world, or against a variety of customized peer groups.

CASE STUDY

In 2009 Marsh carried out a risk quality benchmarking assessment on behalf of a Middle Eastern client; overall in lower middle quartile compared to its peer group.

The benchmarking results helped the client understand industry trends and best practices. An action plan was put in place to drive risk quality improvements; focussing heavily on relatively low-cost enhancements to key management systems and procedures.

Over a seven year period the plant improved significantly, achieving an upper middle quartile position relative to its peer group. Higher quality risks tend to produce fewer losses and unforced outages. No significant capital expenditure was necessary to achieve these impressive results.
